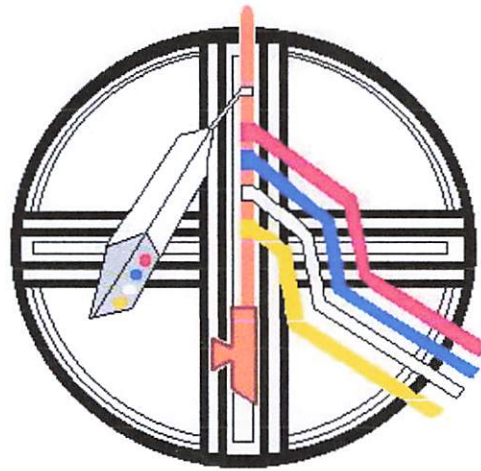
The Appeal Committee will continue to exercise their discretion under Section 9.6(b) of the *Frog Lake First Nations Election Code* to schedule appeal hearings after the appeal filing period (May 26th) has expired. Additional appeals may be filed and this will avoid the need for multiple appeals hearings.

The hearing for this appeal will take place in person. The date, time, location and the manner in which the appeal hearing participants can present their evidence will be set out in a further notice.

In accordance with section 9.6, this notice will be posted within the Band Office and digitally on: 1) Frog Lake First Nation's website; (2) Frog Lake First Nation's app; and (3) Frog Lake First Nation's facebook page.





## Appeal Filing Process

1. Individuals file an appeal directly with the **Clerk of the Election Appeal Committee**, and no other individual. With the following requirements:
  - a. Indicated the grounds for appeal
  - b. Evidence that supports the grounds for appeal
  - c. Sworn before a Public Notary or Commissioner of Oaths
  - d. \$100 filing fee
  
2. The Chair of the Election Appeal Committee will confirm receipt of an appeal to appellant(s) within 24 hours
  
3. The Chair of the Election Appeal Committee will review the application to ensure that requirements are met and:
  - a. Confirm that the appeal will be heard; or
  - b. Dismiss the appeal, and provide written reasons
  
4. If an appeal will be heard: the Chair will issue a notice of appeal to all candidates, impacted parties, electoral officer, which includes:
  - a. Date, Time, Location, within time limits required by the FLFN Election Code
  - b. Copy of the appeal
  - c. Mechanisms for which parties can submit their evidence
